Physical Description:

This collection is comprised of the treasurer's records of the Arundel Casino of Kennebunkport, from 1886-1929, as kept by Sarah P. Bancroft. Miss Bancroft was one of the founders of the Casino, a social organization, and a staunch supporter and hard worker at the club for many years. These papers came via the estate of her long-time companion, and eventual heir, Ellen Sheehan Eldridge (Mrs. John Eldridge).

The collection is largely treasurer's reports, cancelled checks, "Charge Books" (records of charges made by members), and other financial records, but also includes a few copies of local summer newspapers, a few Director's Reports, and a few printed invitations and tickets to Casino functions and events at its sister organization, the Arundel Golf Club, which was also founded by Miss Bancroft.

The collection is stored in nine full and one half box, the ledgers separate, with the newspapers with the newspaper collection as noted in the box and folder breakdown.

Its acquisition number is 83.9.

Sarah P. Bancroft

"Miss Sarah P. Bancroft is again occupying her elegant cottage near the Cliff House. Miss Bancroft has always been a leader in all social matters and a season without her presence would indeed be a dull one."

The Wave, July 8, 1893

Sarah Bancroft was thirty-nine years old in 1882 when she first came to Kennebunkport — a handsome woman, Massachusetts born and bred, the unmarried daughter of a Harvard-educated doctor. She came to Maine by train to visit friends who were summering at Proul's Neck. It was probably on her return trip to Boston that she expressed to the conductor a wish to find a suitable place somewhere in Maine to build a summer cottage. "Miss Bancroft," he said, "Why don't you stop at Kennebunkport?"

Leaving the train at the Kennebunk depot, Miss Bancroft took the stage to

the Bayes House, a small boarding house on Cape Arundel just a stone's throw from the grand Ocean Bluff Hotel (which stood on the site of today's Colony Hotel) and the new Cliff House.

Cape Arundel was still relatively undeveloped when she came. Only two or three architecturally modest cottages had been built on the bluff bordered by the ocean and the Kennebunk River. Miss Bancroft liked what she saw of Cape Arundel with its wildflower-filled fields, stone walls, and pasture gates. We can imagine her deciding, "Yes, there are possibilities here." She bought a piece of land from the Kennebunkport Sea Shore Company, a group of men who envisioned Cape Arundel as a select cottage colony that would turn Kennebunkport into a thriving watering place. Miss Bancroft, more than anyone else, would be responsible for furthering that dream.

She built Bancroft Cottage, a small but elegant house with a tower, narrow stained glass windows, and verandas, that set a new architectural standard for Cape Arundel. She spent her summers there for the next fifty years, arriving each spring from her winter home in Boston's Copley Plaza Hotel, lingering into September.

Miss Bancroft's choice of Kennebunkport for her summer home influenced her friends and acquaintances to do the same. Once here they, like others who had discovered Kennebunkport on their own, looked to Miss Bancroft for guidance socially. As one of the earliest supporters of the Arundel Casino (a hall for musical, theatrical, and literary entertainments); the Kennebunk River Club, which sponsored nautical and sporting events; and the Arundel Golf Club, they respected her status. So too, trusting her breeding and taste, they did not pursue any social enterprise without first finding out what Miss Bancroft thought.

Sarah Bancroft was not, however, simply a socialite. She was an intelligent, energetic, in many ways progressive, woman. (As one admirer liked to point out, "Miss Bancroft is in the patent book." She designed, patented, and manufactured a candle-shaped fixture that when inserted into a candlestick, filled with oil, and its wick lighted, would burn for seven hours.) At Kennebunkport her interest and influence extended beyond the social. She was, for example, instrumental in bringing electricity to Cape Arundel.

Perhaps this is why even as an old woman she was known and respected. She died at Bancroft Cottage on September 23, 1934, at the age of 91, and even though she had largely withdrawn from active social life, the community noted her passing with regret, saying, "Miss Bancroft was the making of Kennebunkport."
