Physical Description:

This collection came to the Museum from the local American Legion chapter, Webber-LeFebre Post, Kennebunk, which evidently acquired it when the Webster Post, No. 9, Grand Army of the Republic, went inactive.

The papers came in a painted, decorated cupboard, which is also part of the collection, and was evidently made to hold the group's records. The papers include local, state, and national publications (General Orders, Circulars, Encampment notices and reports, catalogues and advertisements for various supplies and publications, etc.) as well as local records of membership, meetings, burials, and celebrations. They encompass the dates 1878 - 1915.

This significant study collection is of interest on a local and state level particularly. Webster Post was evidently the first Grand Army of the Republic post started in York County (see Box #1, Folder 7), and was named for Jesse H. Webster, a Civil War veteran who was killed in 1876 during Kennebunk's celebration of the Centennial of the country when an old cannon exploded (see Remich's *History*, pg. 478). It is also of interest because of genealogical data (birthdates, occupations, etc. of members).

The collection is stored in nine boxes and one or two separate locations and bears acquisition numbers 82.43.7 (the bulk of the collection) and 1075. The cupboard is in the manuscript area also.
